



"Harmonized Description and Coding System of the Customs Tariff Schedules of Liberia Act of 2000" and Part III, Chapter 10 of the "Revenue Code of Liberia Act of 2000".

3. In order to be qualified for exemption granted in Count 2, under this Executive Order, the commercial transport company shall be incorporated in Liberia; and that the said company shall enter into a binding contract for at least two years with the Ministry of Transport to provide commercial vehicles on a full-time basis to be used in a professional commercial transport service for the transport of the general public.
4. To qualify for Count 2 incentive, the professional commercial transport service company is required to make a minimum initial capital investment of Fifty Thousand United States Dollars (US\$50,000.00) in the transport sector.
5. The Ministry of Finance shall issue an administrative regulation to operationalize this Executive Order.
6. Importers shall pay only the Customs User Fee (CUF) of 1.5% and the ECOWAS Trade Levy (ETL) of 1% where applicable.

This Executive Order shall take immediate effect on the 1st day of October, A.D., 2010.
