3. A reconciliation of goods dispatched must be kept with references and links to invoices.
 Any losses must be physically recorded with an explanation of how the loss occurred and how the registered trader will minimize the risk of those losses occurring again.
5. Notification of removals under duty suspension must be made in a timely manner.
