The ECOWAS COMMISSION has received financing from the [African Development Fund (ADF)] hereinafter called the Bank toward the cost of the [STREAMLINING TAX, REVENUE MANAGEMENT AND DIGITIZATION OF CUSTOMS ADMINISTRATIONS IN 5 ECOWAS COUNTRIES - MULTINATIONAL (MALI, NIGER, SIERRA LEONE, LIBERIA AND THE GAMBIA)], and intends to apply part of the proceeds toward payments under the contract¹ for Procurement of computer equipment, software and services for the deployment of SIGMAT in Liberia²: "For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit."

The ECOWAS COMMISSION now invites sealed Bids from eligible Bidders for delivery of computer equipment including (Server (02); Firewall (02); All in one Computer (13); All-in-One Laser Printer (05); Switch 24 Ports (05) and provide training .]³ Delivery time was 60 days and delivery place was Monrovia.
3. Bidding will be conducted through the Open Competitive Bidding (national), (OCBN) method as specified in the Bank's Procurement Framework² August 2015, and is open to all eligible bidders as defined in the Procurement Framework.
4. The bidding document in [English] may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee⁵ of [00 USD].⁶ The document will be sent by post at the bidder's expense and can be collected at the address below.⁷
6. Bids must be delivered to the address below state address at the end of this IFB⁸ on or before Mai 28th 2024 at 10 h 00. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below state address at the end of this IFB on Mai 28th 2024 at 10 h 15.
7. All Bids must be accompanied by a "Bid-Securing Declaration
