1. The Liberia Revenue Authority (LRA) has received funds from the Government of Liberia through budgetary allocations and intends to use portion of it to fund eligible payment under the contract for the Procurement of **Public Address System** for its FY 2026 operations.

3. The LRA now invites sealed bids from eligible and qualified bidders for the supply of **Public Address (PA) System**. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the PPCA 2026 and approved by the PPCC and is opened to all eligible bidders.

5. Qualifications requirements: All bids must be accompanied by:

- A Bid Security of **US\$500.00** (*in the form of Managers Check/Bank Guarantee*)
- Valid Tax Clearance
- Valid Business registration with business activity Code: **G4759**.
- Must be Registered on the EGP platform
- Power of Attorney
- Proof of ability to pre-finance
- Proof of Similar goods supplied including contacts of previous and current clients.

6. Bids shall be valid for a period of **ninety (90) days** after the deadline of bid submission.

7. All bid must be accompanied by a bid security of **US\$500.00 (Five Hundred United States Dollar)** and shall be valid for a period of **Twenty-Eight (28) Days** after the tender validity period.

8. Bids must be submitted on the PPCC eProcurement Platform on or before September 2, 2026, at 2:00pm.

9. A complete set of Bidding Document in English can be downloaded on the PPCC eProcurement Platform by interested bidders.

10. Bids will be opened on **September 2, 2026 at 2:30pm**, on the PPCC eProcurement Platform.
