- A Bid Security of **US\$500.00** (*in the form of Managers Check/Bank Guarantee*)
- Valid Tax Clearance
- Valid Business registration with business activity Code: **G4651**.
- Power of Attorney
- Proof of ability to pre-finance
- Proof of Similar goods supplied including contacts of previous and current clients.

6. Bids must be submitted on the PPCC E-procurement platform on or before September 3, 2026 at 2:00 pm.

7. Bids shall be valid for a period of Ninety (90) days after the deadline of bid submission. All Bids must be accompanied with a Bid Security of **US\$1,000.00 (One Thousand United State Dollars)** and shall be valid for the period of **Twenty-eight (28) days** after the Tender validity period.

8. Bids will be opened on September 3, 2026 at 2:30 pm on the PPCC e-procurement platform.
